### Government piddling in the pond

In January the Government announced a plan to give £200m funding to the NHS to buy beds in care homes, hotels etc. to get people out of hospital and free up beds. It is shot through with holes.

It takes no account of where the staff are coming from to turn sticks of furniture into “beds”. It raises serious concerns about how much choice and control people will have, whether they will be bundled into institutions and stranded there or abandoned in unsafe hotel accommodation.

For profiteering in action, you only have to look at the multimillionaire owner of Runwood Homes, the UK’s sixth largest, for-profit care home group. He paid himself £21m in five years despite inspectors finding multiple breaches of staffing, safety and leadership rules, residents left in dirty incontinence pads, staff accused of rough handling.

### Some successes on care charging

Great lobbying by disabled people’s organisations and others managed to get the Government to agree to rises in line with inflation in both the personal expenses allowance for local authority-supported care home residents and the minimum income guarantee (MIG) for people receiving LA arranged care and support not in a care home. Hancock froze MIG and PEA from the Care Act onwards. Javid raised them by 3% last year. The struggle continues to get the Government to fund Local Authorities to implement these commitments without more cuts in other areas.

### Hot press: BBC exposes debt recovery

Working with disabled people’s organisations, the BBC has highlighted that “more than 60,000 adults with disabilities and long-term illnesses in England were chased for debts by councils last year after failing to pay for their social care support at home” Research by the BBC last year found that in 22 councils, charges had risen by the equivalent of £500 per person supported, since 2018-19.

Claimants told the BBC this month that they can't afford the charges amid rising food and rent prices, plus the additional costs of living with disabilities. Councils took legal action against 330 people in 2021-22. Some disabled people said they felt they had little choice but to live without home care, others feared bailiffs being called in over unpaid debts. <https://www.bbc.co.uk/news/uk-64668729>

### Workers fight back and fight together

The start of the year saw spreading strikes by nurses, ambulance workers, physios, rail workers, teachers, posties, civil servants, university staff etc., and a big jump in trade union membership. Care and support workers remain constrained by privatisation and fragmentation but Hestia workers have been out on strike again in Hounslow and public sector trade unions continue to battle to make inroads.



On February 1<sup>st</sup> workers rallied and marched across the country protesting against anti – strike legislation in the pipeline and expressing solidarity with workers taking industrial action. Look out for more collective action on budget day, 15<sup>th</sup> March.

## Campaigners take to the streets

On January 28<sup>th</sup> SOSNHS & KEEP OUR NHS PUBLIC organised action across the country to END THE CRISIS IN THE NHS, which is impossible without addressing the broken state of social care and community health services. MP Margaret Greenwood talked about what we can do and Lord Prem Sikka talked about universal, free social care and support being not just necessary but feasible, ending with a rallying cry: “the point is that the money is available but what is not available is the political will.
